Indian Institute of Technology Bombay, an Institute of national importance, is looking for suitable person for the following posts for its 65 bedded hospital having a well equipped operation theatre and headed by the Incharge Hospital, CMO (SAG) supported by a number of Medical Officers, Visiting Specialists, etc. The Hospital caters to the medical needs of the employees, their families and students. **This is a rolling advertisement. 1. Part Time Medical Officer :

Qualification & Experience : M.B.B.S. Degree from recognized university with one year experience as general duty medical officer.

Honorarium / Salary : Rs.35000/- per month.

Appointment Type : 28 hours per week on 89 days basis.

2. Full Time Medical Officer :

Qualification & Experience : M.B.B.S. Degree from Indian Medical Council recognized university with one year experience as general duty medical officer.

Honorarium / Salary : Rs.50000 to 70000/- per month
plus Rs.5000/- Non Practicing Allowance (NPA) per month.

Annual Increment : Rs.5000/-

Appointment Type : On contract for a period of 89 days.

Age Limit : 40 Years

General Information :

- 1) All posts are temporary and on consolidated salary.
- 2) The post of Full Time Medical Officer is residential and License Fee free unfurnished accommodation will be provided.
- 3) Persons employed in Government/Semi Government Organization or Educational Institutions must apply through proper channel OR shall provide No Objection Certificate alongwith application for the post of Full-time Medical Officer. Candidates will be required to produce relieving letter at the time of joining, if selected.

- 4) Certificate in support of experience should be in proper format i.e. it should be on the organizations letter head, bear the date of issue, specific period of work, salary, name and designation of the issuing authority along with their signature and stamp.
