GENERAL INFORMATION / DETAILS ABOUT POSTS

- 1) Posts carry allowances like House Rent, Transport and Children's Education as admissible to Central Government employees posted in Pune.
- 2) Faculty is eligible for medical facility as per the Institute norms & LTC facility as per the Government of India Norms
- 3) Posts are covered under New Pension Scheme of Govt. of India.

- 4) The qualifications prescribed should have been obtained from recognized Universities / Institution.
- 5) Applications from the candidates working in Government Departments / Government Funded Institutes / Government Funded Research Agencies / Universities must be sent through proper channel and with a clear certificate that the applicant will be relieved within one month of receipt of appointment order, if selected. However, an online application to be submitted before the last date as an advance copy.
- 6) The prescribed Essential Qualifications / Experience indicated are bare minimum and mere possession of same will not entitle candidates to be called for the selection process. Where number of applications received in response to an advertisement is large, it may not be convenient or possible for the Institute to call all eligible candidates for selection process. The Institute may restrict the number of candidates to be called for selection process to a reasonable limit, on the basis of qualifications and experience higher than that of the minimum prescribed in the advertisement. - 11) Candidates selected for appointment will have to produce Caste certificate / Caste Validity Certificate / Non Creamy Layer certificate (in case of OBC candidates) as applicable during the selection process OR after joining the Institute within the stipulated period stated in the offer letter.
