Applications are invited for the following post tenable at TIFR, Mumbai.

CONSULTANT (CIVIL):

Qualification:

- (a) M.E. (Civil Engineering) from a reputed College / Institute.

Eligibility Criteria:

- (a) The candidate should be well acquainted with the functioning of Central Government Ministries / Departments.
- (b) The candidate who have retired from the post of Chief Engineer (7 CPC level 14 or above) or equivalent posts from CPWD/DCSEM or any other Central Government Departments can only apply.

Desirable Skills:

- (a) Up to date knowledge of Government of India rules and regulations etc.
- (b) Possess good written and oral communication skills.
- (c) High integrity and commitment for working for long hours.

Brief Scope of Work/Job Responsibility:

- (a) Advise and help TIFR in interaction with the Architectural consultancy firm on all matters. TIFR is in the process of appointment of Architectural consultancy firm for Providing Comprehensive Architectural consultancy Services for Preparation of Redevelopment Master Plan, Comprehensive Architectural Consultancy for new building and Structural and functional Audit of existing Buildings for TIFR, Colaba, Mumbai which is in the final stage and the Architect firm is likely to be appointed in few months.
- (b) Advise and help TIFR in monitoring, supervising and evaluating the work of Architect in executing the project.
- (c) Advise and help TIFR in making Detailed Project Report (DPR) for all the construction projects as per the requirement of Department of Atomic Energy (DAE).
- (d) Advise and help TIFR in selection of project monitoring consultant (PMC) for the said above project.
- (e) Advise and help in other matters referred to him by TIFR and/or Chief Engineer, TSR.

Nature of Appointment:

- (a) The appointment is full time and will be purely on contract basis.
- (b) The selected candidate should have own accommodation in and around Mumbai. No accommodation or HRA will be provided by TIFR.
- (c) The contract would be for a period of one year.

Incomplete applications and applications received after the last date shall not be considered.

The candidates are required to produce following original documents with copies at the time of interview:

- (b) Identity Proof (Adhar Card / Election Card / PAN Card / Passport / Driving License).
- (c) Date of birth/Proof of age.
- (d) Educational Qualification (all mark sheets and passing certificates).
- (e) Experience certificate/s.
- (f) Reference certificates from two referees.
- (g) Outstation candidates called for interview will be paid III A/C return train fare for the journey by the shortest route from the nearest railway station of their place of residence on the production of photocopies of onward and return journey tickets. Those candidate/s who travel by air are required to travel only by the national carrier, AIR INDIA with the tickets purchased from (a) Air India website or booking counter or (b) through Government authorised travel agents viz. Balmer Lawrie & Co. Ltd., Ashok Travels & Tours and IRCTC. The air-fares for such candidates will be restricted to III A/C return train fare on production of tickets and boarding passes.
