3. PRE-REQUISITES:

A) <u>PRE-REQUISITES FOR THE POST OF REGIONAL DIRCTOR/EXECUTIVE DIRECTOR</u>:

Qualification: Bachelor's Degree or Master's Degree in Electrical Engineering / Technology or its equivalent.

Preferable: Two years full time or three years part time Post Graduate Degree or Post Graduate Diploma in Management/ Administration with specialization in Marketing / Finance OR Degree in Law.

Experience: Must possess 20 years post qualification experience in Power Sector. At least 05 years experience should have been in a position having high responsibility such as Superintending Engineer and above, out of which 01 year in a position such as Chief Engineer/ Head of the Department or its equivalent in Power Sector.

<u>Method of filling</u> : By direct recruitment on contract basis for a maximum period of 03 years. Beyond 03 years, these posts would be evaluated and decision will be taken by the Competent Authority.

Note (i): for the post of Regional director/Executive Director, the departmental candidate possessing Degree in Engineering/ Technology in any other discipline and who fulfill the condition of required experience shall be considered under direct recruitment provided that they will have to appear for Selection Process and compete along with other candidates.

4. UPPER AGE LIMIT:

- 4.1 Upper age limit is 52 years up to last date of submission of application. i.e. 18/02/2019.
- 4.2 Upper age limit for MSEDCL employees will be 57 years.
- 4.3 Date of birth as per Secondary School Certificate (SSC) and age as on 18/02/2019 should be mentioned in the application.

5. **RESERVATION**:

5.1 Maharashtra State Public Services (Reservation for Schedule Castes, Schedule Tribes, Denotified Tribes (Vimukta Jatis), Nomadic Tribes, Special Backward Class and Other Backward Classes) Act 2001 has been enforced by the Govt.of Maharashtra from 29th January, 2004 and the provision under Government of Maharashtra Circular No. CBC-2013/P.K.182/DTNT/-1 dated 17/08/2013, the principle of Creamy-Layer has been made applicable to VJ(A), NT(B), NT(C), NT(D), OBC, SBC & SEBC categories whereas Schedule Castes and Scheduled Tribes category are exempted. The candidates should produce **current years Non-Creamy Layer Certificate** in the prescribed form issued by appropriate authority as per the notification issued by Govt. of Maharashtra from time to time.

- 5.2 For claiming and availing benefit of reservation under Backward Class category, the candidates should produce a caste validity certificate issued by the competent Caste Scrutiny Committee. The candidates applying without caste validity certificate of caste claimed, if selected, will be appointed provisionally only after submission of proof of submission of necessary documents to appropriate Caste Scrutiny Committee for caste validity as per G.R.No.BCC-2009/P.No.291/09/16-B dated 05/11/2009 & G.R.No.BCC-2011/P.No.1064/2011/16-B dated 12/12/2011.
- 5.3 The caste certificate issued by appropriate Competent Authority of Maharashtra State only will be considered as valid for availing the benefit of reservation including benefit in the payment of application fees. Caste notified in other State as reserved will be treated as Open for all the purposes.
 - The candidates should belong to categories notified by the Maharashtra State viz (a) Scheduled castes (including SC category person who has adopted Buddhist Religion) (b) Scheduled Tribes (c) VJ-A, NT-B, NT-C, NT-D, (d) Special Backward Class, (e) Other Backward Class and (f) Socially and Educationally Backward Class.
 - (ii) The candidates applied under Socially and Educationally Backward Classes shall produce cast certificate issued by the appropriate authority as per G.R.No.BCC-10/2018/P.K.130/BCR dated 07/12/2018.
 - (iii) The cast certificate issued to the candidates under Educationally and Socially Backward Category (ESBC) as per the G.R.No.CBC-10/2013/ P.K.35/BCR dated 15/07/2014 earlier will be valid for availing reservation under SEBC.
 - (iv) The candidate applying under SEBC should be domicile of Maharashtra State.
 - (v) Once the caste/tribe is mentioned in application form, it cannot be changed at any stage later on.

6 METHODOLOGY OF SELECTION:

6.1 The candidates will be shortlisted for selection process taking into consideration the qualification, experience, job responsibility etc. mentioned in the application.

- 6.2 The departmental candidates of MSEDCL will be given preferential weightage while drawing the select list.
- 6.3 The applicants shortlisted for selection process will be intimated through email only.
- 6.4 The recruitment in MSEDCL is done strictly as per merit in a systematic way giving appropriate weightage to various selection tools.
- 6.5 Canvassing in any form will disqualify a candidate.
- 6.6 If any false/ incorrect information is furnished by the candidate is detected at any stage of recruitment process, his/her candidature will not be considered and if detected afterwards, the appointment shall be cancelled.
