Eligibility Qualifications for the posts of ASSISTANT PROFESSOR in LAW

- (i) Good academic record as defined by the concerned university with at least **55% marks** (or an equivalent grade in a point scale wherever grading system is followed) at the **Master's Degree level (LL.M.)** from an Indian University, or an equivalent degree from an accredited foreign university.
- (ii) A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differently-abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.

- (iii) A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19th September, 1991.
- (iv) A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.
- (v) Besides fulfilling the above qualifications, the candidate must have cleared the **National Eligibility Test (NET)** conducted by the UGC, CSIR or similar test accredited by the UGC like **SLET/SET**.

Provided that candidates who have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulation, 2009, or the University Grants Commission (Minimum Standards and Procedure for Award of M. Phil/Ph.D. Degree) Regulation, 2016, and their subsequent amendments from time to time, as the case may be, shall be exempted from the requirement of the minimum eligibility condition of NET /SET.

Provided further that the award of degree to candidates registered for the M. Phil/Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Bye-laws / Regulations of the Institutions awarding the degree. All such Ph.D. candidates shall be exempted from the requirement of NET/ SET subject to the fulfillment of the following conditions:

- a) The Ph.D. degree of the candidate has been awarded in regular mode only;
- b) The Ph.D. thesis has been evaluated by at least two examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal; and
- e) The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/seminars/sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic affairs) of the University concerned.

NOTES, INSTRUCTIONS, TERMS & CONDITIONS :

1. Candidates must read all the instructions before filling the application form. Also candidates must ensure that no column is wrongly filled in application form as the information furnished therein would be used for deciding the eligibility and suitability for being called for the interview. Application not filled in correctly, incomplete or not as per the instructions is liable to be rejected and the responsibility of such rejection would be on the candidate himself/herself.

2. **Self-attested copies of the certificates should be attached in support of information given and claim for concession/ relaxation in the form, wherever necessary,** and serial No. of enclosure attached should be indicated in the respective column given in the form. Any information contained in the attached certificates shall not be considered unless it is claimed in the application form.
3. **The pay scale and other conditions of employment shall be as per the Resolutions/Circulars issued by the Government of Maharashtra from time to time and the statutes and ordinances of the university.**
4. As shown below, grade "B" in the 7-Point scale with letter grades O, A, B, C, D, E & F shall be regarded as **equivalent to 55%**.

5. **DULY FILLED IN "PROFORMA-A", SUPPLIED ALONGWITH THE APPLICATION FORM, SHOULD ALSO BE SUBMITTED ALONGWITH THE APPLICATION FORM. FAILURE TO SUBMIT "PROFORMA-A" WOULD MAKE THE APPLICATION LIABLE FOR REJECTION.**
6. The minimum period of probation shall be one year extendable by a maximum period of one more year, in case of unsatisfactory performance.
7. Candidates belonging to the reserved categories specified by the state Government of Maharashtra only shall be considered for the posts reserved in this advertisement. The candidates from reserved category who are domiciled outside the State of Maharashtra will be treated as Open category candidates as per Maharashtra Govt. Circular No. CBS-1290/23116/Pra.Kra.378/ Mapak.5, dated 24-08-1995.
8. As per the Govt. Resolution No. Aniyo-1005/126/Seva-4 dated 31st October, 2005 a new "Defined contribution pension scheme" has been made applicable to the Govt. servant, who are recruited on or after 1st November, 2005. The same is applicable to employees of the University also.
9. The candidate shall have to submit a **Declaration-II** of the Application Form as per the rules Prescribed by the Govt. of Maharashtra in respect of small family vide Notification No. SRV.2000/CR/(17/2000) XII, dated 28-03-2005.
10. Candidates applying against the reserved post should also attach self-attested copies of Caste certificate and Caste Validity certificate and Non-creamy layer certificate, wherever applicable.

11. **An application in any other format other than the prescribed one shall be treated as invalid and shall be summarily rejected.**
12. **Completed application form in legal size alongwith self-attested copies of certificates / testimonials in **ELEVEN SETS** should be submitted alongwith Registration fee (Non-refundable) of Rs.500/- for open category or Rs.300/- for reserved categories by way of demand draft (The Demand Draft must be placed/tagged at the top of the application) drawn in favour of "Finance & Accounts Officer, Rashtrasant Tukadoji Maharaj Nagpur University, Nagpur".**
13. Applicant must write the advt. no., name of the post, category, his/her name and full address (with mobile number) on the back of the Demand Draft without fail.
14. Paste **(do not staple/pin)** a passport size colour photograph in the space provided on the right top portion of the application duly attested by the applicant in **at least two application forms.**
15. Canvassing in any form throughout the Selection Process will be a disqualification.
16. **Applications incomplete in any respect will be liable to be rejected.**
17. The right to fill or not to fill the posts or to modify/alter/cancel the advertisement is reserved by the University.
18. All disputes arising out of this advertisement are subject to Nagpur jurisdiction.
19. Proficiency in Marathi language is desirable.
20. Applicants shall not be entitled for any TA/DA towards attending the interview.
21. Selection will be made on the basis of candidate's previous record and performance during his/her interview. The University may also utilize seminar/colloquium and/or any other mode as a method of selection.
22. The University shall not be held responsible for postponement or cancellation of scheduled interview for any unforeseen/unavoidable reasons.
23. **Application form of in-service candidate must be signed and forwarded by his/her present employer. However, in case of an "anticipated delay" an applicant may submit the advance copy of his/her application along with the original Demand Draft. In the event of applications duly forwarded by the employer not reaching the Registrar within the stipulated time, the applicant concerned shall be required to furnish a "No Objection Certificate" from his/her employer, at the time of interview, in the absence of which he/she shall not be entitled to appear for the interview.**
