In addition, the selected candidate shall be paid conveyance charges as follows:

- a) In case of local travel (up to 30 kms one way) conveyance charges may be given on actual basis with upper ceiling of Rs. 4500/- per month, with approval of the Unit Head.
- b) In case of long distance travel (beyond 30 kms one way) conveyance charges may be given on actual basis with upper ceiling of Rs.6000/- per month, on case to case basis, with approval of the Unit Head.

- 2. All candidates applying for the above posts must be registered with Medical Council of India or State Medical Council.

- 3. The engagement is purely on temporary basis- for a period of 1 year at the time of initial appointment. Subsequent renewal(s) of term can be for a maximum period of three years at the discretion of management. There will be one month notice period on either side.
- 4. There is no reservation for SC, ST and OBC. All applicants will be treated under UR category.
