- 3. The right to fill or not to fill the post or to modify/alter/cancel the advertisement is reserved by the University.
- 4. All disputes arising out of this advertisement are subject to the jurisdiction of competent court in Nagpur.
- 5. Proficiency in Marathi language is essential.
- 6. Prescribed Educational Qualifications, Experience & other conditions would be as per the Government Resolutions of Department of Higher & Technical Education, Maharashtra State & as amended/approved by the Government of Maharashtra from time to time. The other Government Resolutions/Circulars issued by the Government of Maharashtra from time to time will be made applicable.
- 7. Self-attested copies of the certificates should be attached in support of information given in the form where necessary and Serial No. of enclosure attached should be indicated in the respective column given in the form. Any information contained in the attached certificates shall not be considered unless it is claimed in the application form.
- 10. The candidate should submit his/her Bio-data alogwith the application form.

- 12. The period of time taken by candidates to acquire M. Phil. and/or Ph.D. Degree shall not be considered as teaching/research experience to be claimed for appointment to the post of REGISTRAR.
- 13. The candidates from reserved category who are domiciled outside the State of Maharashtra will be treated as OPEN category candidates as per Maharashtra Govt. Circular No.CBS-1290/23116/Pra.Kra.378/ Mapak.5, dated 24<sup>th</sup> August, 1995.
- 14. As per the Govt. Resolution No. Aniyo-1005/126/Seva-4 dated 31<sup>st</sup> October, 2005 a new "Defined contribution pension scheme" has been made applicable to the Govt. servant, who are recruited on or after 1<sup>st</sup> November, 2005. The same will be applicable to employees of this Institute.
- 15. The candidate shall have to submit a <u>Declaration-II</u> of the Application Form as per the rules Prescribed by the Govt. of Maharashtra in respect of small family vide Notification No. SRV.2000/CR/(17/2000) XII, dated 28<sup>th</sup> March, 2005.

- 16. Candidates should also attach self-attested copies of Caste certificate, Caste Validity certificate and Non-creamy layer certificate, wherever applicable.

- 19. Paste (do not staple/pin) a passport size colour photograph in the space provided on the right top portion of the application form, duly attested by the applicant in at least two sets of the application forms.
- 20. Canvassing in any form throughout the selection process will be a disqualification.
- 21. Applications incomplete in any respect will be liable to be rejected.
- 22. Applicants shall not be entitled to any TA/DA towards attending the interview.
- 23. On verification of documents supplied by the applicant if it is found that the information received from an applicant is false or is based on false certificates the applicant shall render himself liable for legal action and the interview/selection will be immediately cancelled.
- 24. Candidates are advised to satisfy themselves before applying that they possess the prescribed qualifications and it is for the candidates themselves to ensure that they possess the prescribed qualifications. No inquiry asking for advice as to eligibility will be entertained.
