**Applications are invited for Emeritus Scientist (ES)**

The National Centre for Cell Science invites applications from superannuated scientists / or those scientists who are due for superannuation in next six months, and have significant pre-retirement accomplishments in the areas of microbial research for engagement as Emeritus Scientist on contractual basis. The tenure of contract shall initially be for 03 years which shall be reviewed on annual basis. The tenure may further be extended by 02 more years on a year to year basis, subject to assessment by a Review Committee. In case of premature cessation of tenure by either party (ES or NCCS), a notice of one month would be required. The conditions such as eligibility, remuneration etc. will be as under:

**1. Eligibility:**

- i. Should have superannuated or due for superannuation from the post of Scientist in Level – 14 of Pay Matrix or equivalent or above.
- ii. Outstanding track record during the last 5 years as evidenced by mentoring PhD students, publications in reputed journals, technology developed, consultancies offered to external bodies, patents endorsed for filing etc. Proven track record in management of a large microbial culture collection. Extensive research experience in the area of microbial taxonomy & diversity and human microbiome research.
- iii. Familiarity with Bio- Diversity Act 2002 and its implications on Microbial research.
- iv. Election to prestigious professional societies and scientific academies or recipient of prestigious awards or track records of involvement in scientific advisory bodies or eloquence in science narration or members of Scientific Task Force etc.
- v. Proven leadership quality, leading international portfolios in line with national demand.
- vi. At least 20 years of independent experience in microbial research and working at the interface of basic and public health research.
- vii. Age normally not more than 62 years at the time of being considered for the position.

**2. Remuneration:**

They would be paid monthly consolidated remuneration of Rs. 1,00,000/-. No other allowances / perquisites whatsoever will be permissible.

**3. Duties and responsibilities:**

- i. Assist in continuing and fortifying the Institute's capabilities in the areas of basic and applied research particularly in the area of microbial research and microbiomics.
