2. A detailed academic CV including a complete list of publications.

4. A short research proposal not exceeding 2-3 pages (excluding bibliography and figures) including the origin and significance of the problem, the objectives and research methodology.

5. The candidate should have submitted thesis by **June 30, 2021**. An intimation of the same with relevant proof should be sent to the above email ID on or **before June 30, 2021**.
