ICMR-National Institute of Virology (NIV) & ICMR-National AIDS Research Institute (NARI) are the premier research institutes under the aegis of the Indian Council of Medical Research (ICMR), Department of Health Research, Ministry of Health & Family Welfare, Government of India.

ICMR-NIV & ICMR-NARI intends to engage the following Non-Institutional Project Human Resource Positions, purely on temporary contract basis. Under the PM-Ayushman Bharat Health Infrastructure Mission (PM-ABHIM), four regional NIVs (at Bangalore, Jabalpur, Dibrugarh and one north Zone Centre) and National Institute for One Health at Nagpur are being established by the Government of India through DHR-ICMR-NIV. A division for Research on Disease Elimination Sciences & Health as a Satellite Centre of NARI are being setup by NARI, Pune.

A Program Management Implementation Unit (PMIU), is to be established in ICMR-NIV & ICMR-NARI, Pune for effective implementation of the proposals approved under PM-ABHIM Scheme. For the PMIU in NIV & NARI, the Competent Authority has approved following four positions (combined), to be engaged, purely on temorary basis and consolidated remuneration without involving creation of any regular post, on the following eligibility criteria, defined specifically for the PMIU of this flagship programme, to be completed in a time-bound manner. The following workforce will look after all the PM-ABHIM projects, both at ICMR-NIV and ICMR-NARI. The initial appointment is for one year, to be renewed annually, based on the performance of the candidate, functional requirement and budgetary provisions of the Institute.

There is no need to send any certificates/documents along with the hard-copy of application.
- 2. Late and incomplete online applications or applications not submitted through online or application submitted in any other format or hard copy of online application not submitted in time or hard copy of online application without signature and photo etc. will not be considered. Candidates are therefore advised to submit their applications well in time without waiting for the last date for submission of online application.
- 3. Number of positions may vary.
- 4. These positions are meant for temporary projects and co-terminus with the project.
- 5. Engagement of the above advertised Project Human Resource Positions will depend upon availability of funds, functional requirements and approval of the Competent Authority. - 16. The persons engaged on Project Human Resource Positions cannot be permitted to register for Ph.D., due to time constraints.
- 17. The persons engaged on Project Human Resource Positions will normally be posted at the study site; however, they can be posted to any other sites in the interest of research work. They are liable to serve in any part of the country.
- 18. The candidates selected for the post of Engineer (Civil) will require to travel frequently to the sites & TA/DA will be paid as per rules.
- 19. The persons engaged on Project Human Resource Positions shall **not** have any claim on a regular post in ICMR or in any of its Institutes/Centers or in any Department of Government of India and their project term with breaks or without breaks in any or multiple projects will not confer any right for further assignment or transfer to any other project or appointment / absorption / regularization of service in funding agency or in ICMR.
