Applications are invited for filling up the following temporary technical posts at ICAR Directorate of Floricultural Research, College of Agriculture Campus, Shivaji Nagar, Pune under the administrative control of Indian Council of Agricultural Research :

General instructions for candidates :

1. All posts are temporary but likely to continue. At present place of posting is in Pune. However, selected candidates can be transferred to any where in India in any of the ICAR Research Institute/ NRCs/ Directorate/Bureau etc. of ICAR.
2. Number of posts indicated above are tentative which may increase or decrease.
3. These posts are Non-Government but pensionable under New Pension Scheme introduced by Govt. of India w.e.f. 1.1.2004 and service conditions are mutatis mutandis as applicable to Indian Council of Agricultural Research employees and as amended from time to time.
4. Age :18 to 30 years. Upper age limit relaxation upto 5 years for SC/ST candidate, 3 years for OBC candidate. There will be no age limit for ICAR employees in technical category. SC/ST/OBC/PH Certificates should be in the prescribed format applicable for the Central Govt. job requirement.
5. The age relaxation in the upper age limit for **RAs/SRFs** who worked continuously in different projects of DFR/ICAR will be to the extent of their spell they were actually engaged as RAs/SRFs in different projects of DFR/ICAR subject to a maximum of 16 years 3 months. Inordinate spell of above 6 months will be treated as break in continuous engagement and age relaxation will not be available. This dispensation is only for relaxing the maximum age limit and does not imply any other relaxation whatsoever regarding essential qualifications / experience etc. RAs/SRFs want age relaxation must have to produce Original Certificate in respect of his / her claim at the time of selection / appointment / interview failing which age relaxation will not be given.
6. Crucial date for determining the age limit of candidates for each post will be as on **01.01.2015**
7. Persons already in employment should route their applications through proper channel only. In case a candidate anticipates delay in forwarding of his / her application through proper channel, he / she must send an advance copy of the application along with fee which must reach this office on or before the closing date. The application of such employee will be considered only after receipt of application through proper channel.
8. The prescribed qualifications are minimum and enhanced qualification do not entitle candidates to be called for written test/interview. Where the number of applications received in response to advertisement is large and it will not be convenient OR possible for the Institute to call for test/interview to all candidates, the Director, ICAR- DFR, Pune reserves the right to fix the criteria for calling the candidates. After screening the applications the candidates may be called for written test/Interview.
9. Applications should be submitted in the prescribed proforma strictly typed/hand written. The Candidates applying for the above post should ensure that they fulfill all eligibility conditions viz. essential qualification / age etc. It may be noted that the equivalent qualification should be in the subject Horticulture

or Agriculture only and no other qualification will be considered under equivalent qualification. Their admission at all the stages of the recruitment will be purely provisional subject to satisfying the prescribed eligibility conditions. In view of the anticipated large number of applicants, scrutiny of the eligibility and other aspects will not be undertaken before the Written Examination and therefore, the Candidature will be accepted only provisionally. Candidates are advised to go through the requirements of educational qualification, age etc. and satisfy themselves that they are eligible for the posts, before applying. Candidate must attached self attested / attested copies of education / technical qualification, experience, Date of Birth, cast certificate i.e SC /ST / OBC or /PH which should be in the prescribed proforma applicable for Central Govt job alongwith with application. Mere issue of admission certificate for written test to the candidate will not imply that his / her candidature has been finally cleared by the Office. Verification of eligibility conditions, age and other with reference to original documents will be taken up only from those candidates who qualify in the written examination. When scrutiny is undertaken after the written examination, if any claim made in the application / document / information is not found substantiated, found false / misleading at later stage even after appointment, the candidature / appointment will be cancelled / services will be terminated and the decision of the Director, DFR in this regard shall be final.

10. Application form must accompany with a Bank Draft of Rs. 250/- (SC/ ST / Women / Physically Handicapped / Ex-serviceman candidates are exempted) drawn in favour of •ICAR Unit €DFR, payable at Pune. **No other means of payment i.e. IPO / money orders will be accepted failing which the application will be rejected.** The date of bank draft should not be prior to the date of issue of the advertisement in the Employment News and the same should be valid for a period of six months. Candidate must write his/her name on the back side of the Bank Draft. The application fee is non refundable.
11. No TA/DA will be paid for appearing in written test examination.
12. No correspondence will be entertained from the candidates for selection/test/ interview / appointment. Canvassing in any form will disqualify a candidate.
13. Government strives to have a workforce which reflects gender balance and women candidates are encouraged to apply. Women candidates fulfilling the requirements for the post are encouraged to apply against the recruitment advertisement. 16. **Applications received after expiry of the last date will not be considered and entertained and no correspondence in this regard will be made.** Candidates in their own interest are advised to submit their applications well in time and before the last date to avoid possible delay in postal transit. Institute will not be responsible for any postal delay.

Applicants are advised to check their emails at regular intervals.
