Advertisement for the post of Wildlife Veterinarian

The Zoo Authority of Maharashtra has been created to provide for proper development and maintenance of recognized Zoos in the state of Maharashtra so as to make them modern Zoological parks, to monitor the implementation of the developments plans, schemes as well as maintenances of works in the zoos in Maharashtra as approved by the State Government and in accordance with the regulations issued from time to time by the Central Zoo Authority.

In pursuance of the above objectives, this office is in need of an experienced Wildlife Veterinarian on contract basis.

Eligibility criteria:

1) Age: Not more than 62 years

2) Essential educational qualification:

Graduate in veterinary science with requisite registration from veterinary council of India. Post Graduate in any discipline of veterinary science. In exceptional cases condition of post gradation may be relaxed for highly desirable candidates having rich experience of Zoos.

3) Essential experience :

Not less than 2 years of experience after Post Graduation as Zoo veterinarian / wildlife veterinarian or as a wildlife veterinary research experience

4) Desirable educational qualification and experience:

Post-graduation in wildlife veterinary science. Post graduate diploma in wildlife, experience in Ex-citu conservation of wild animal species.

5) Physical Health:

Candidate should be physically fit to travel extensively throughout Maharashtra.

Duties of the wildlife Veterinarian: Wildlife veterinarian is expected to work as technical expert for the authority. He will visit all the zoos in Maharashtra periodically and inspect the zoos and write the report as per CZA norms for veterinary care. He is expected to be in tune with modern practices in veterinary care of wildlife.

Important contract conditions:


Contract shall be for 2 years which shall be extendable to 5 years (2+2+1) depending on satisfactory performance, which will be reviewed after the end of each contract period. Remuneration of ₹ 45000/- will be paid in first year. Appropriate revision of remuneration will be done at the end of each year. Travelling allowance and daily allowance will be paid equivalent to the veterinary officer (Grade Pay - 5400) of the Government of Maharashtra.

Candidate will be appointed on purely contract basis with no claim for permanency.

Successful candidate shall sign an agreement with the 'The Zoo Authority of Maharashtra,.

How to apply:

Candidates are requested to send their application with bio data on or before 1st February, 2017. Candidates are requested to attach at least two reference letters from persons in the relevant field under whom candidate has either worked or studied.
